## **SILICIUS announces a rugby tournament and strengthens its commitment to the sport**

- **The tournament will be organized in Las Terrazas, field of the Alcobendas Rugby Club, for the U-12 Category**
- **It will count on the participation of the Swiss team Zug Rugby Club and Mazabi Santander**

**Madrid, May 20, 2022.** SILICIUS Real Estate, SOCIMI (Spanish REIT) specialized in the management of long-term properties with stable income, has announced the organization of the SILICIUS Tournament for the U-12 Category that will take place on Saturday, May 21, in Las Terrazas, field of the Alcobendas Rugby Club, which will act as the host team.

In addition, the Spanish under-8-9-10 rugby

championship will also take place, reason why SILICIUS has mobilized the presence of several of these schools.

The organization of the SILICIUS Tournament is part of the SOCIMI's commitment to support this sport and, more specifically, to the values that characterize rugby such as teamwork, perseverance or respect, and that SILICIUS integrates into each of its business activities.

In this context, Juan Diaz de Bustamante, Managing Director of SILICIUS, stressed that "the schools promote values such as respect, humility, effort, integration and passion, which characterize rugby and that the company incorporates as its own in its activity. Through this sponsorship, SILICIUS also participates in the different solidarity actions that the clubs develop".

As a precedent, SILICIUS has been incorporating actions to support children's sport during the last two years through financial aid to different schools of rugby clubs in which various training activities are promoted with great value among the little ones. In addition, the entity maintains actions to support other sports such as sailing. Specifically, in 2019, the company supported Daniel de la Pedraja and Iker Martínez's boat, the M&G Tressis Silicius GC32, due to its participation in the King's Cup.
